"\$5 Million 2012 Tax Opportunity"

Thus far, national politics has ignored the issue of gift and estate taxes. As you know, the level of estate and gift tax protection currently \$5,120,000.00, drops to only \$1 million per person on January 1, 2013. The likelihood of cooperation between Congress and the President on this issue dwindles daily. The "1% vs. 99%" debate, which is likely to negatively shape presidential politics in 2012, only reinforces this conclusion.



This is extremely important to you and your family. Let's assume that you are a married couple and have a \$4 million estate, keeping in mind that your estate includes your retirement accounts, your life insurance, and all real property. If deaths occur in or after 2013, over \$1 million will go to the government upon your passing. If you are a single person and have a \$4 million dollar estate, over \$1.6 million will go to the government upon your passing.
