# Special Holiday Greeting from Michael Gilfix: "A Year in Review"



The past year, 2012, presented a number of challenges and opportunities. We have the implementation of the Affordable Care Act (Obama Care), which will begin in the year 2013. It will change the health insurance and heath care system landscapes. We see some bright spots and we have some concerns. Time will tell.

The world of <u>estate tax planning</u> has been a challenge. We endured uncertainty throughout 2012.

Many of you obtained a copy of my book, published early in 2012. It is entitled, <u>Beat Estate Tax Forever: The Unprecedented \$5 Million Opportunity in 2012</u>. The book was extraordinarily well received. It generated interest and countless calls to our office.

We were surprised when, at the 11<sup>th</sup> hour, Congress and our President seemingly solidified the \$5 million level of estate tax protection. We are optimistic this will remain in place into the distant future. We know, however, that delimiting changes are possible.

In 2012, we also had the publication of first draft regulations to implement Federal Medicaid law that was passed by Congress in the year 2006. This is the Deficit Reduction Act of 2005 (DRA). California is the only state in the country that has not yet implemented this legislation. Until it is

formally implemented – perhaps in late 2013 – remarkable opportunities exist to protect assets and qualify for Medi-Cal to pay the cost of skilled nursing care, in particular.

Once the DRA is implemented, the rules will be tighter. Other planning opportunities will still exist.

This year will be very exciting for all of us. We will have our annual <u>Special Needs Trust Community Conference</u> in Palo Alto on Tuesday, April 2<sup>nd</sup>. In 2012, we had over 200 attendees. It was a wonderful success for us and for the many nonprofit organizations that participated and distributed information to attendees.

We will continue to offer special services to all members of the Peace of Mind program. With that in mind, we attach the updated list of POM member benefits.
