

## **Recent Questions from POM Members**

When one member of the Peace of Mind Program submits a question, it is probable that others have the same question. For this reason, we identify recent questions we have received and our summary responses.

**Question:** My husband and I have an AB Trust. I am about to inherit \$350,000 from my mother's estate. How will I title those assets after I receive them?

**Answer:** When a married individual inherits money, the money is her separate property. This means that she has complete ownership and control of it.

Once it is inherited, she has two choices. First, she can retain its "separate property" status. This means that she would retain complete control of the asset. It also means that, if there is ever a divorce, all of those funds remain with her.

Alternatively, she can convert those assets to "community property." In effect, this is a gift of a half interest to her husband. This means that she would be giving up a half interest in the asset and she would be giving up her exclusive control.

Either way, inherited assets must be titled in her trust to be sure probate is avoided.

**Question:** We established Family Protection Trusts for each of our two children. When we did so, we did not believe that our daughter would be able to manage her own trust. We named someone else as trustee. We now believe that she is able to do so and would like to make a change. Can we do so?

**Answer:** Particularly since your daughter's trust is not yet funded – it is in existence but is empty – you can change its terms in any way you like. These are irrevocable trusts, but nothing prevents you from replacing them with new trusts and with different terms before such trusts are funded. If assets are already in the trust and there is a need to make a change, it can be more difficult.

the cost of long-term care. Attendees were surprised to learn of the many planning tools that are available to achieve these goals.



#### **Communicating with Medical Care Providers for Quality Care**
