## Attorneys Michael Gilfix and Myra Gerson Gilfix are the 2020 Recipients of the Theresa Award

Michael Gilfix and Myra Gerson Gilfix were jointly awarded the Theresa Award, given annually to individuals who distinguish themselves for exceptional services to individuals with disabilities. Based in Lido Beach, New York, the Theresa Foundation has worked for years to enhance and enlarge services for individuals with disabilities.

The Theresa Foundation provides a grant of \$5,000 to non-profit organizations identified by the annual award recipients. Accordingly, Michael and Myra designated two organizations in Santa Clara County to share the award. One is the Pacific Autism Center for Education (PACE), based in Santa Clara, California. The other is Life Services Alternatives (LSA), based in San Jose. PACE provides a panoply of educational and other services as well as group homes. LSA has

raised millions of dollars to purchase land and build group homes in Santa Clara County.
